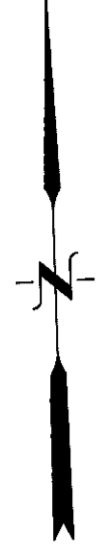
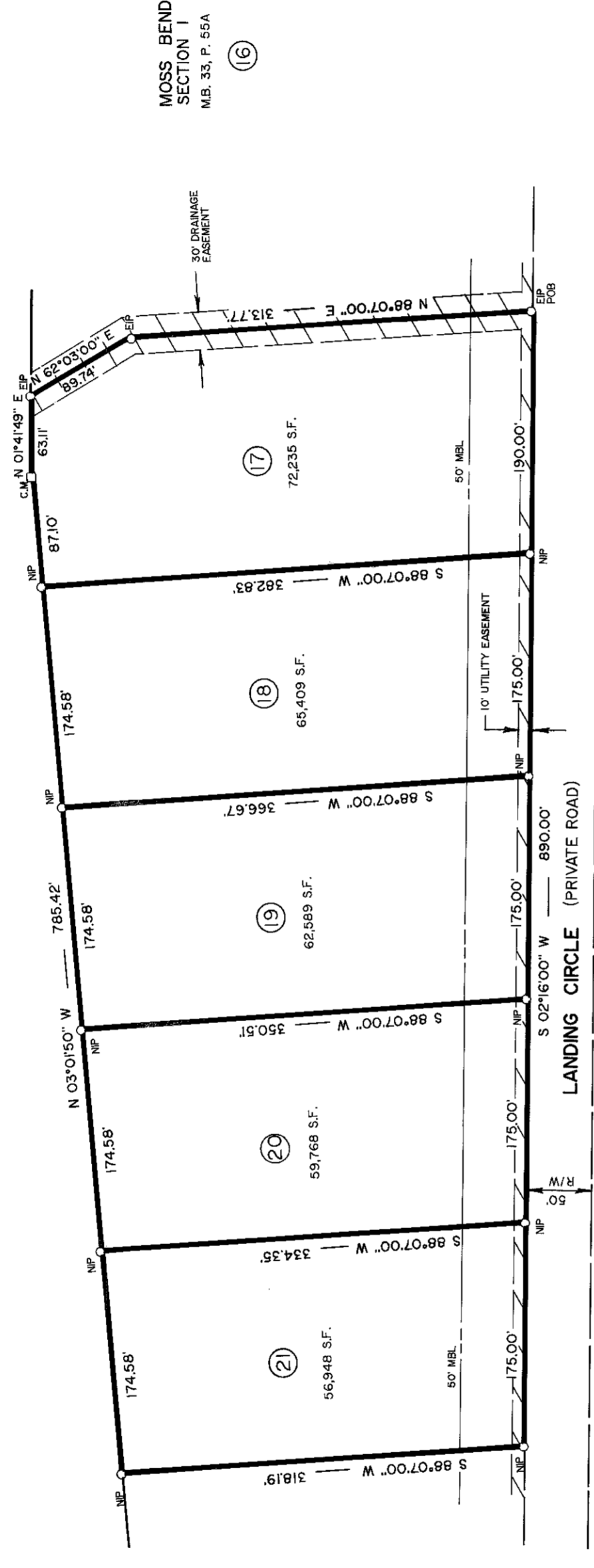


VICINITY MAP

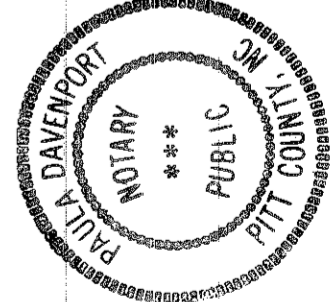
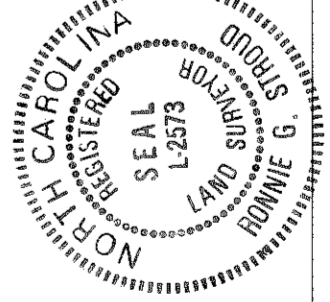
